At present OHP operates primarily in south Europe, Africa and Latin America.



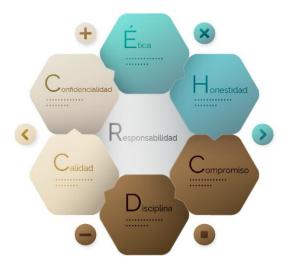
Our Values
